OPERATIONAL SETUP AND PERFORMANCE

Appeal Decisions

POPLA has a key performance indicator (KPI) requiring decisions to be issued within 55 days of the appeal submission. 28 days of this period can be taken up by the time allowed for the operator to respond and an appellant to comment on the operator's evidence. This can leave 27 days for POPLA to assess and issue a decision.

For the period 1 October 2023 to 30 September 2024, 92% of the 64,808 appeals handled by POPLA had a decision issued within our KPI requirements.

Calls

For the period up to 30 September 2024, POPLA handled 17,011 inbound calls. Of these, 96% were answered within 30 seconds.

Appeals Charter

The introduction of the Appeals Charter in the British Parking Association (BPA) and International Parking Community (IPC) Code of Practice meant a change to our handling of appeals. In addition to deciding whether parking charges were valid, we would be required to assess whether parking operators had handled appeals in line with the new expectations.


Throughout the period in question, we were preparing for this change. We worked across the organisation to digest the new Code of Practice and began to develop our decision-making principles based on the new standards. This was developed into a robust training and quality framework to ensure that Assessors are well positioned to make accurate and meaningful decisions following its introduction.

Consumer Feedback

During the period, 17,778 motorists responded to our satisfaction surveys, each providing valuable feedback on our process. This feedback gives us the opportunity to continually develop and improve our ways of workings.

Motorists frequently reference the simplicity and efficiency of submitting appeals with us, the usefulness of updates throughout the process and the clarity of our decisions.

A small number of motorists who are less confident with digital channels have shared feedback about the challenges of a predominantly online process. While we offer accessible alternatives to our service, this feedback has reinforced our commitment to continuously improving the usability of our online system, making it easier to navigate for all users and enhancing our overall reach and impact across the industry.
